BRICS SYSTEM UPDATES

- Dep. B. Vedra, Technician
 - Hamilton Electric is a new user on the system.
 - Stats- 9.75 M PTT's in 2015. 8 Busies over 20 channels
 - School Radios- all schools except New Miami have applied and received radios. 2 Lakota schools, St John and St Joes are awaiting installation.
 - Invoices- \$51,000 outstanding bills
 - Social Media- Radio Security policy updates have been requested. We have received complaints of monitoring encrypted talkgroups and posting on Social Media sites. A revised policy will be presented to the board at the next meeting. Chief Dickey would like to make sure the agency administrator is notified of any violations. This is only possible if the violations are reported to BRICS. We do not have someone monitoring the known sites.
 - The Microwave system is nearing the end of life. We are required to have the upgrade in place with the 7.19 release. It is in the Capital Plan for 2016, but this money is not released until later in the year. There should be an update for the board at the March meeting.
 - ZONE 004 updates- Hamilton County/Cincinati, Montgomery County, Miami County and New Paris will be connected to this zone.
 - Border Agencies- Discussin on neighboring agencies receiving Mains. Local talkgroups do not roam outside of Butler County. Neighboring agencies have our LAW, TAC and FIRE talkgroups.

- L. Green- Will radios need to be replaced in 2 years? Capt Franke, if it breaks, possibily. We may be able to piece meal parts to extend the life of the subscriber units.

GOOD OF THE ORDER

- West Chester was not billed \$25 for mobiles. Tanya Kaiser will look at it. Additionally, there is still outstanding maintenance showing from 5 years ago. Capt Franke states we will report back at the next meeting on a resolution.
- BCEO Rep Fritz Stitsinger has retired from BCEO. We need to get a new appointment from them.
- D. Dick questions if BRICS maintains repair figures. Capt Franke- BRICS monitors repairs. Portables cost \$393 and Mobiles cost \$465 to send to the Depot. We plan on 10% of the radios to fail and have to be sent to the Depot per year. The Commissioners have committed to maintaining the ind=frastructure. Locals are to maintain subscriber units. Committee is looking at the future subscriber units. The Advisory Board needs to look at this as support for the XTS/XTL Series ends in 2018. Decisions need to be made soon to meet local budgetary needs.
- Capt. Franke- we will be looking to the Advisory Board to request inventory updates in the very near future. Agencies have radios sitting on the shelf that have not been used. We will need these radios to extend the useful life of the subscribers.
- The next meeting is March 24, 2016


